Meeting minutes (protocol) General Assembly 30-05-2025, Tabor, Czech Republic

Initially 17 member present with voting right, starting item 9 Poland delegate arrived, 18 members present with voting right.

1.Welcome address of President

Vice-President mrs. Stocchi opens the General Assembly and informs the meeting that the GA will be chaired by mr. Fagos to replace former president mr. Bispo.

2. Election of protocol writer

This item is by mistake on the agenda and something from the past. Statutes art 10-3 stipulate: "Minutes must be taken of the proceedings at each meeting by the secretary, which must be adopted and signed by the President and the secretary"

3. Approval of the presidents annual report 2024

Mr. Beuks stated 17 members present with voting right. Mr. Bispo started a discussion about the proxy of Russia and asked the member to decide. As this was not on the agenda and not all members being present this request was rejected. The annual report of the president voting: 16 in favor, 1 against

4. Approval of General Secretary Annual report 2024

17 in favor

5. Approval annual report Responsible for Working 202417 in favor

6.Approval financial annual report 2024 of the Treasurer 17 in favor

7. Approval of auditor report 2024

17 in favor

8 Approval of the judges commissions annual report 2024

Mr. Anders Härnman gave short additional text to the committee and requested to add this to the annual report which will be taken care off.

Voting judges commissions report 16 in favor, 1 abstention

9. Approval of the Show Commissions annual report 2024

From this moment 18 members with voting right present as the Poland delegate arrived. Result of voting Show Commissions report: 12 in favor, 6 abstentions

10. Approval of Health Commissions report 2024

11 in favor, 7 against

11. Election of 3 persons for the voting commission

Elected were Martina Sarwatka, Dominika Susterova and Trine Larsen

12. Discharge of the Presidium

18 in favor.

13. Elections of the Presidium of Atibox for period 2025-2028

Again a discussion was started about the voting right of Russia (by proxy for mr. Bispo). Henry Beuks explained there are 2 reason for rejecting this voting right: First of all, in the past the statutes about payments for the annual fee were changed and became more strict because of payments were done in the past coming from individuals from other countries for other countries, including Russia. Statutes say now payment has to come from either bankaccount of the club of bankaccount of committee member of the club involved. The Russian payment came from Montenegro, in their first letter Russian club stated the accountholder was "member", in a 2nd letter he was "committee member'. The committee asked for proof but until today the Committee did not receive it yet.

The 2nd ground for rejecting is that the Committee received a letter of the president of the Russian Boxer Club giving proxy to mr. Bispo, but also days before the GA an email from the secretary of the Russian Boxer Club stating they don't want to give proxy to anyone. The Atibox Committee does not want to be involved into internal problems of the Russian Boxer Club and the Committee has no idea because letter of the president and mail of secretary are in contradiction, what is true or not.

Greece, Portugal and Sweden handed out a letter requesting to let the GA vote about the voting right for Russia, but as this is not an item on the agenda that is sent out to all members and not all members being present, voting would be against statutes.

Voting by simple majority for:

President: mr. Fagos 12 votes, mr. Bispo 6 votes

1st Vice-President: Mr. Härnman 6 votes, Mr. Izquierdo 12 votes

2nd Vice-President: Mr. Härnman 8 votes, Mrs. Beatrice Stocchi 10 votes

General Secretary: Mr. Nigel Rallings 10 votes, Mr. Kurt Kiekens 8 votes

Treasurer: Mr. Drudi 8 votes, Mr. Beuks 10 votes

Responsible for working: Mr. Garcia, 15 votes, 3 abstain

Assessor 1: Mr. Wolff 2 votes, Mr. Haugen 2 votes, Mrs. De Bake 8 votes, Mr. Milea 6 votes. Second voting round: Mrs. Milea 10 votes, mrs. De Bake 8 votes

Assessor 2: Mr. Wolff 8 votes, Mr. Haugen 1 vote, Mrs. De Bake 9 votes, second voting round: **Mr. Wolff 10 votes**, Mrs. De Bake 8 votes

14. Election of 2 auditors: Martina Sarwatka (IBC Germany) and Trine Larsen (Norway)

15. Proposal of Portugal:

Proposal A: 7 in favor, 11 abstain

Proposal B: 8 in favor, 3 against, 7 abstain

Proposal C: no voting, mr. Beuks explained this proposal gives president extradecisive vote in **all cases** when votes are equal, which can be in certain cases against the Dutch WBTR law, in which law there are limitations giving a person or entity more than 1 vote in a company board or committees of associations.

16. Confirmation of Atibox events

- Show's 2027 2028 2029: no applications, GA approves unanimously: Atibox Show 2027 San Marino, 2028 Spain 2029 Slovakia (2026 was decided earlier Portugal)

-Boxer Major: GA approves unanimously: 2025 no application, 2026 San Marino, 2027 and 2028 no applications

WM IGP&IFH: GA approves all below unanimously:

2025: Made public during GA: Slovakia and Czech Republic will organize together 2025

2026: Portugal applied as only candidate for 2026

2027: Made public during GA: Spain
