Dear sir or madam!

We represent the Union of Specialists in the Diagnostics of Animal Genetic Diseases (gen-ok.ru), which collects and analyzes data on genetic diseases in dogs.

We are currently interested in genetic diseases of Boxer, which can be divided into two groups:

1. Genetically determined diseases that must be monitored before breeding to reduce the incidence of the disease in the breed.

2. Genetically determined diseases that cannot be monitored before breeding due to their later development (for example, some ophthalmological and cardiac diseases).

Questions: What diseases do you consider essential for pre-breeding screening? What genetic diseases do you recommend monitoring for, regardless of whether the dog is used for breeding? There are likely a number of diseases that are not subject to mandatory monitoring, but which you still recommend monitoring for.

Your opinion is very important to us. We would be grateful if you could help us by sharing your experience and approach to managing these diseases, as they have an extremely negative impact on a dog's quality of life.
